Tharminder graduated from the University of Wolverhampton prior to being admitted as an Advocate & Solicitor of the High Court of Malaya in 1998.

Prior to co-founding Izral Partnership in 2008 with Mohd Izral Khairy & Wong Guo Bin, Tharminder had been with Messrs. Logan Sabapathy & Co. where he was appointed as a partner in 2007.

His clientele include various high profile individuals and leading corporations, for whom he regulates act in relation to various types of both contentious & non-contentious matters – in particular, corporate-related ones such as oppression proceedings, derivative actions, breach of directors’ duties, breach of shareholders’ agreement, capital market misconducts, rehabilitation of corporations etc.

Tharminder is a natural strategist. Having learnt at a young age that litigation decisions must most importantly promote the clients’ commercial interests, he has had well over 20 years of training to make some of the most challenging & demanding strategic decisions when it comes to litigating for his clients. His “*astute knowledge and conduct in strategic legal matters*” have been described by a client as “*meritorious*”.

Given that, he plays a crucial role in the firm’s asset preservation & asset recovery matters where strategic planning & execution is key. He is a sought-after counsel by clients to apply for *or* resist injunctive relief applications in



courts – such as prohibitory injunctions, *Fortuna* injunctions (restraining presentation of winding-up petitions), *Mareva* orders (asset freezing), and *Anton Piller* orders (asset search & seizure).

He has also successfully represented a public listed oil & gas corporation as well as its subsidiaries in one of the largest corporate restructuring exercise in Malaysia in recent times – which involved obtaining of numerous restraining orders in his clients’ favour.

Besides court matters, Tharminder is also experienced in alternative dispute resolution. On the international front, he acted for a Swiss luxury bespoke watch maker in an arbitration proceeding under the auspices of the International Chamber of Commerce (ICC) involving a contractual dispute with an image right holding company incorporated in an offshore jurisdiction. This dispute involved *inter alia* laws of England, Switzerland, and Spain which required him to work closely with reputable counsel from those jurisdictions.

Locally, he acted for a prominent developing arm of a Malaysian government-linked corporation in a multi-million ringgit construction arbitration under the auspices of the Asian International Arbitration Centre (formerly known as the Kuala Lumpur Regional Centre for Arbitration).

Quite apart, Tharminder also holds a Certificate in Adjudication from Asian International Arbitration Centre (formerly known as the Kuala Lumpur Regional Centre for Arbitration). Besides having acted as an Adjudicator in a number of construction adjudication matters, Tharminder has also regularly acted as counsel for a prominent local developer in adjudication proceedings



under the Construction Industry Payment and Adjudication Act, 2012.

Tharminder is a 'Recommended Lawyer' in The Legal 500 (Asia Pacific) – which has recognised him as one of the “*key partners*” in Izral Partnership, and also for his invaluable contribution in the aforesaid “*contentious restructuring matter*”.
